Thompson retiring; committee begins search for new director

At the Council's meeting in May, Pat Thompson announced she will retire from ACEJMC summer 2025. She has served as executive director of ACEJMC since 2018. Following her announcement, Council members gave Pat a well-deserved standing ovation. We are better and stronger because of Pat's commitment to ACEJMC. Pat will be recognized and celebrated next year. Details to follow.

Moving forward

A search committee has been formed and a job description drafted, which will soon be available on the Council's website and distributed to program directors, as well as Council and Committee members. The application deadline for the position is Friday, Dec. 6, and interviews are expected to take place in February or March next year.

Search committee members are: Del Galloway, chair, Greg Pitts, Marie Hardin, Rafael Lorente, Peter Bhatia and Dorothy Bland. Thompson will serve as ex-officio.

New noncompliance policy to start with 2024-25 accreditation reviews

A new policy approved by ACEJMC in 2023 will require accredited or reaccredited units with a standard out of compliance to demonstrate, within three years, that the deficiencies have been rectified.

The policy ensures ACEJMC is in compliance with Council for Higher Education
Accreditation requirements.
CHEA is the agency that formally recognizes ACEJMC to accredit programs for professional education in journalism and mass communications in institutions of higher learning.

Beginning in the 2024-25

academic year, if the Council accredits or reaccredits a school that the site team has cited for a noncompliance on a standard, the school must submit a report to ACEJMC within a year outlining its plans to correct deficiencies. The report should note issues that may delay quickly achieving compliance. Within the next two years, the school will be required to submit a final report with evidence that the deficiencies in the noncompliant standard have been resolved.

A Council-appointed panel will review the school statement and will report its findings to the Council.

2023-24 Accreditation Decisions

American University -- Marnel Niles Goins is the new dean of the School of Communications. She succeeds Leena Jayaswal, who served as interim dean.

American University in Dubai -- Marta Rebolledo is the new associate dean for the Mohammed Bin Rashid School for Communication.

California State University, Fullerton -- Micheal McAlexander is serving as acting chair of the Department of Communications while Jason Shepard serves as interim dean of the College of Communications.

Howard University -- Chukwuka "Chuka" Onwumechili is serving as interim dean of the Cathy Hughes School of Communications. He succeeds Gracie Lawson-Borders, who stepped down and returned to faculty after serving as dean since 2013.

Indiana University -- Suzannah Evans Comfort is the new director of the Journalism Unit in the Media School. She succeeds Gerry Lanosga, who is serving as interim associate dean for academic affairs for the Media School.

San José State University -- John Delacruz will become director of the School of Journalism and Mass Communications, effective with the start of the fall semester. He will succeed Phylis West-Johnson, who is returning full time to faculty after serving as director for eight years.

Southern Illinois University Edwardsville -- Suman Mishra has been named chair of the Department of Mass Communications. She succeeds Musonda Kapatamoyo, who completed his six-year term rotation as chair and returned full time to faculty.

University of Memphis -- Matthew Haught was named chair of the Department of Journalism and Strategic Media. He succeeds David Arant, who stepped down after serving 16 years in the leadership role and is now a professor emeritus.

Accreditation Lapse

REQUIRED ANNUAL REPORTING

Retention, graduation data update by Aug. 15

Accredited programs are required to publish current student retention and graduation data on their website and to update the data annually by Aug. 15.

Notification of the updated data must be sent to ACEJMC, directed to Cindy Reinardy at creinardy@ku.edu.

Data are to be posted in a prominent, easy-to-find place on the accredited unit's website.

Programs undergoing initial accreditation review are required to have data posted before their site visit.

Searchable database

ACEJMC's searchable database is expected to be complete in spring 2025.

The database will provide objective and current data of all ACEJMC accredited programs in one place. A digital tool will allow users to compare accredited programs side-by-side, including information about degrees offered, fees and tuition, enrollment and faculty numbers, internships, and travel abroad opportunities.

Schools have been required to self-report data directly into the database since 2018-19 as part of their self-study process for site team reviews and continue annual updates. Schools on the 2024-25 review schedule are the last group to cycle through under the new database requirement.

Initiatives Update

ACEJMC to launch new branding in September

Last year, ACEJMC conducted a brand research study to understand the perceptions and beliefs of Council and Committee members relative to their knowledge of the organization and its mission. The research had a 72% response rate. The results informed the development of the council's new brand and visual identity (featured here), which will be launched in early September. The new identity will be reflected on the Council's website, as well as in our annual booklet, stationary and other collateral materials.

A Seal of Accreditation will also launch in September. Accredited programs may feature the seal on their website and in promotional materials, ensuring they follow required guidelines.

Standards review continues

Every 10 years, ACEJMC launches a major review of our accreditation standards. In 2021, a number of changes were made to modernize our standards. These included eliminating the required 72 outside credits and reducing the number of standards by combining faculty-related topics into a single standard. We clarified and strengthened the governance and assessment standards. We added a broader focus for reviewing diversity and inclusiveness and we renumbered the standards.

Feedback from program reviews, site teams and Council and Committee discussions reminds us to think actively about our accreditation standards and the guidance site team members receive for their reviews.

An Ad Hoc committee consisting of Council members Dorothy Bland, Heidi de Laubenfels and Greg Pitts will review the standards during the coming academic year. As we have in the past when changes to standards have been recommended, there will be ample time devoted to receiving input from school directors, Accrediting Committee and Accrediting Council members, site team members and others. Engagement Committee: new name, new members

Last year the Council approved a new bylaw objective: *To advo*cate for the value of education in journalism and mass communications in championing democratic values as the foundation of a diverse and inclusive society.

To support this commitment, an "Advocacy Committee" was created. Its first item of business was to listen to valued stakeholders: program directors, Council and Committee members, AEJMC and ASJMC members and others. At its March meeting earlier this year, ASJMC hosted a panel discussion of our Advocacy Committee – a terrific opportunity to hear directly from folks their hopes, concerns and guidance.

A key outcome of those discussions was to consider renaming the committee from "Advocacy" to something that better reflects the work of the committee. The result is a new name - Engagement Committee - which aligns

with the group's intent to engage with stakeholders that share a common commitment - to advance higher education and journalism and mass communications, more specifically. Feedback also included appointing additional educators to the Committee, which has happened.

Our Engagement Committee will be of counsel to ACEJMC's executive committee, offering informed guidance as we interpret - and possibly - respond to attacks on journalism and mass communications education. The committee's work will include monitoring state and federal legislation that impacts the work of ACEJMC.

The Engagement Committee is chaired by Mike Cherenson and includes Marie Hardin, Steve Geimann, Rosanna Fiske, Dan Shelley, Gracie Lawson-Borders and Jessica Pucci.
